The position is responsible for managing employee leaves of absences, Agency benefit programs and providing support to Agency Health and Wellness programs and initiatives. The position works with management to ensure attendance and benefits management is appropriately leveraged to drive organizational results while ensuring employees at all levels are supported. The Human Resources Supervisor oversees the Health and Safety Program and supervises the Health and Safety Officer.
